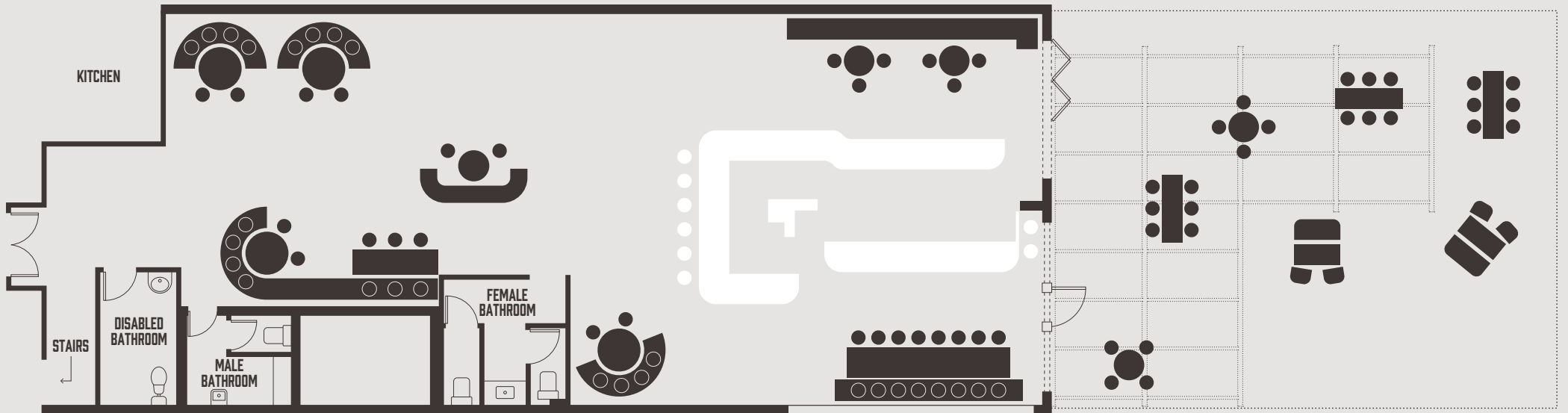

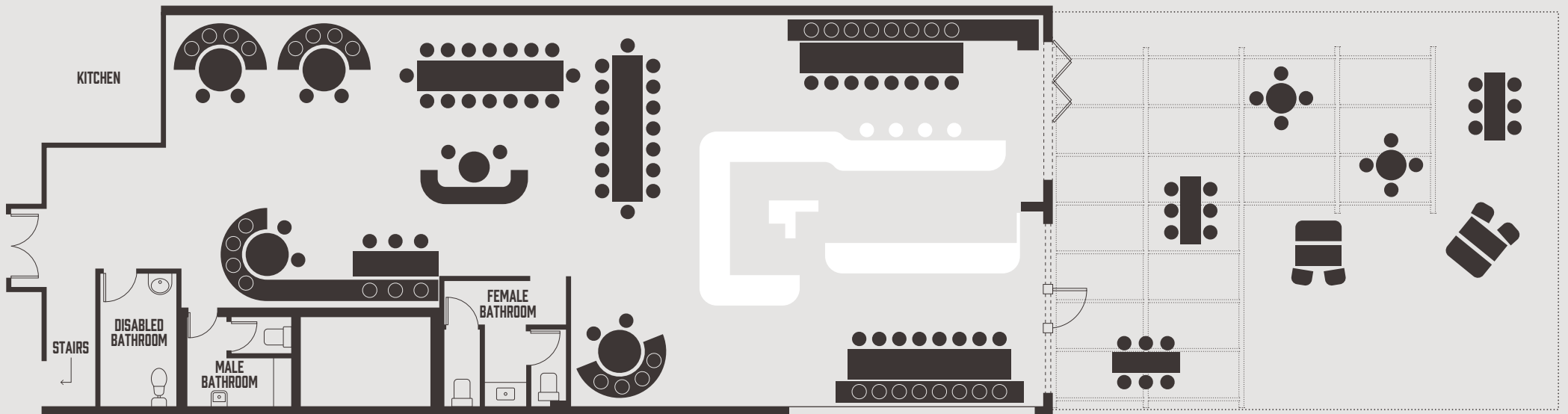
STANDING: INSIDE 140

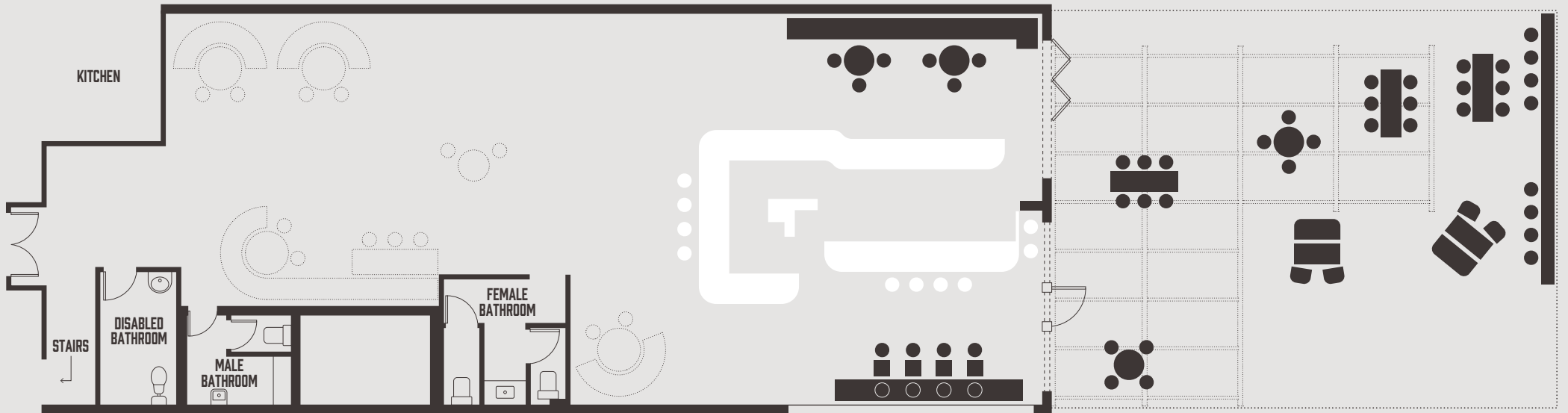
SEATING: INSIDE 90

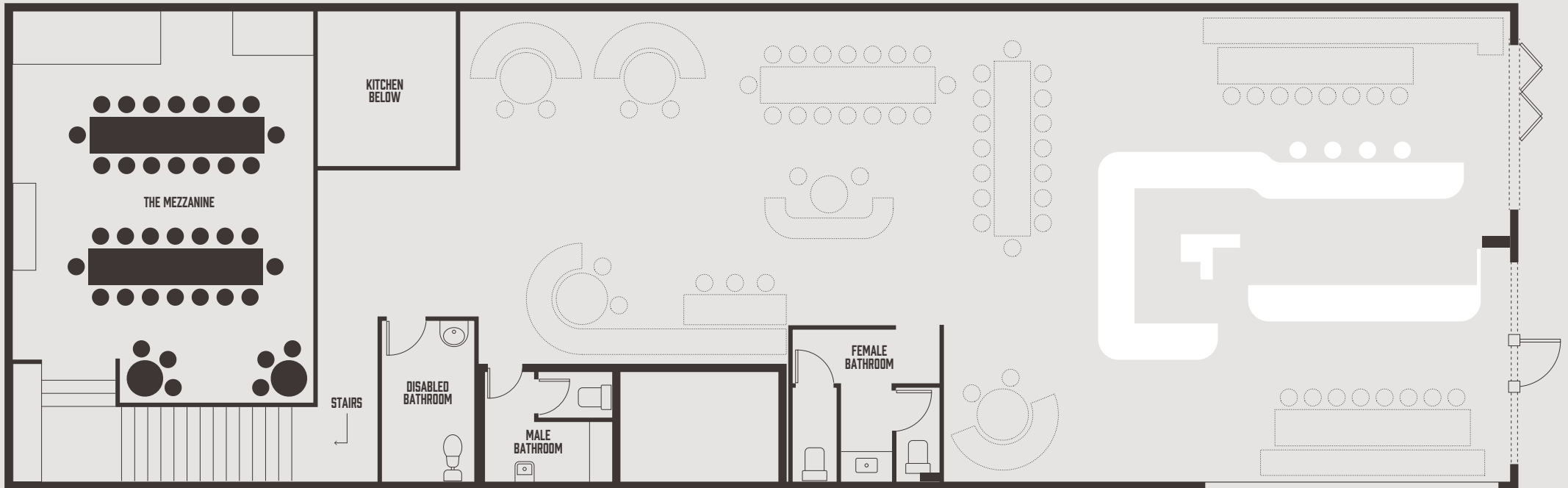
STAND-UP: OUTSIDE 90

BOOKING CONFIRMATION

Bookings can be secured by the payment of \$100 for major functions. Any additional outstanding charges are to be finalized at the conclusion of the event. Exclusive functions must be finalized prior to function day. Meet Me At Mary's accepts most major credit cards and cash payments.

CANCELLATION

Meet Me At Mary's must be notified of all cancellations in writing to the Manager.

Deposits paid are refundable up to 30 days prior to the function date. If the function was cancelled less than 30 days prior to the date of the function, the deposit will not be refunded. For cancellations 14 days or less to a function, the full minimum spend amount will be charged.
